- 2. SUMMARY: THE PUBLIC BICKERING BETWEEN THE THREE COLOMBIANS WHO MET WITH PABLO ESCOBAR'S WIFE IN DECEMBER (REFTEL), COMBINED WITH THE PROTESTATIONS TO POLOFF OF ONE OF THOSE INVOLVED, APPEARS TO CONFIRM OUR BELIEF THE GAVIRIA ADMINISTRATION HAD NOTHING TO DO WITH THESE CONTACTS, AND THOSE INVOLVED WERE ACTING PURELY OUT OF SELF-INTEREST. END SUMMARY.
- 3. THE FIRST OF PABLO ESCOBAR'S LATEST THREE LETTERS DEMANDING CONCESSIONS AND THREATENING VIOLENCE (REFTEL) WAS ADDRESSED TO THREE COLOMBIAN OFFICIALS, ONE OF WHOM (MEDELLIN SENATOR ALVARO URIBE VELEZ) CALLED ON POLOFF AT THE EMBASSY JANUARY 26 TO EXPLAIN HIS VERSION OF EVENTS AND CLARIFY HIS ROLE. ESCOBAR'S LETTER REFERRED TO THE VISIT OF THE THREE (THE OTHER TWO BEING MEDELLIN REGIONAL PROCURADOR IVAN VELASQUEZ AND EX-CONSERVATIVE SENATOR ALVARO VILLEGAS) WITH ESCOBAR'S WIFE, AND CONTAINED THINLY-VEILED THREATS AGAINST FISCAL GENERAL CONFIDENTIAL

- 4. URIBE EXPLAINED TO POLOFF THAT DURING A DECEMBER 24 SECURITY MEETING WITH MEDELLIN POLITICIANS WHICH INCLUDED MEDELLIN MAYOR LUIS ALFREDO RAMOS, THE REGIONAL FISCAL, AND REGIONAL PROCURADOR VELASQUEZ (THE PROCURADURIA ACTS AS AN INDEPENDENT GOVERNMENT WATCHDOG AGENCY), "SOMEONE" MENTIONED THAT THE REAL REASON ESCOBAR HAD NOT SURRENDERED WAS THAT HE FEARED HE WOULD BE KILLED. URIBE REPLIED IF THAT WAS THE ONLY OBSTACLE, HE WOULD BE MORE THAN WILLING TO ACT AS A GUARANTOR OF ESCOBAR'S SAFETY.
- 5. AT THIS POINT, ACCORDING TO URIBE, VELASQUEZ SAID HE KNEW ESCOBAR'S MOTHER, AND COULD PROBABLY ARRANGE A MEETING WITH HER FOR URIBE, WHO COULD RELAY HIS WILLINGNESS TO GUARANTEE ESCOBAR'S SAFETY IF HE SURRENDERED. A FEW DAYS LATER VELASQUEZ CALLED TO SAY EVERYTHING WAS SET, AND THAT EX-SENATOR AND CONSERVATIVE PARTY LEADER ALVARO VILLEGAS WOULD ACCOMPANY THEM. THE THREE WERE NOT ALLOWED TO BRING BODYGUARDS, AND WENT UNACCOMPANIED TO AN APARTMENT TO MEET, NOT ESCOBAR'S MOTHER, BUT HIS WIFE. URIBE SAID HE DID NOT REALIZE

6. URIBE SAID HE EMPHASIZED TO MRS. ESCOBAR THAT HE HAD NO AUTHORITY TO NEGOTIATE, AND HIS VISIT WAS NOT CONFIDENTIAL

HE EXPRESSED HIS DEEP CONCERN ABOUT THE VIOLENCE, AND THAT HE WAS WILLING TO DO WHATEVER NECESSARY TO ENSURE THAT ESCOBAR IS ALLOWED TO SURRENDER PEACEFULLY. HE TOLD MRS. ESCOBAR THAT MEDELLIN DESPERATELY NEEDED PEACE, AND THAT PRESIDENT GAVIRIA'S SURRENDER DECREES WERE THE BEST MECHANISM TO ACHIEVE THIS.

7. ACCORDING TO URIBE, MRS. ESCOBAR WAS VERY DISCREET, REPLYING WITH GENERALITIES ABOUT THE "DIFFICULTY OF THE

SITUATION." URIBE SAID SHE MAY HAVE BEEN COACHED BY LAWYERS TO SAY AS LITTLE AS POSSIBLE. ACCORDING TO URIBE, WORD ON THE STREETS IS THAT SHE IS EMBARRASSED BY ESCOBAR'S TERRORISM AND SHUNNED BY NEIGHBORS. THE PEOPLE OF MEDELLIN ARE ANGRY AT ESCOBAR AND THE NUMBER OF SYMPATHIZERS IS CONSTANTLY SHRINKING. THE MEETING ENDED WITH NO AGREEMENTS REACHED. 8. DURING THE MEETING WITH POLOFF, URIBE CONSTANTLY PACED THE SMALL OFFICE; HE WAS VISIBLY AGITATED. HE SAID HE WANTED THE EMBASSY TO BE AWARE OF HIS EXACT ROLE

THE RESULT OF THE ENVIGADO AFFAIR. HE SAID GAVIRIA

- 9. URIBE SAID HE FEARED FOR HIS LIFE AND THAT OF HIS FAMILY, AND THAT HE WAS CONSIDERING MOVING HIS FAMILY TO BOGOTA. HE HAS NOT CONSIDERED LEAVING THE COUNTRY BECAUSE HE COULD NOT AFFORD IT, AND HE HIMSELF CANNOT LEAVE MEDELLIN BECAUSE OF HIS RESPONSIBILITIES AS A REPRESENTATIVE OF THE PEOPLE THERE.
- 10. DURING A FEBRUARY 3 LUNCH, LIBERAL MEDELLIN SENATOR LUIS GUILLERMO VELEZ TOLD POLOFF HE BELIEVES IT WAS URIBE WHO INITIATED THE CONTACT WITH ESCOBAR'S MOTHER. VELEZ REMINDED POLOFF THAT URIBE IS A COUSIN OF THE OCHOAS VASQUEZ NARCO TRAFFICKING FAMILY (MANY OF WHOM ARE IN PRISON AT ITAGUI), WHO HAVE FINANCED HIS POLITICAL CAMPAIGN. ESCOBAR, THROUGH THE OCHOAS, IS NOW DEMANDING URIBE RETURN THE FAVORS BY TRYING TO OPEN A COMMUNICATION CHANNEL TO GAVIRIA. IN A SEPARATE MEETING FEBRUARY 4, FORMER ANTIOQUIA SENATOR ALEJANDRO GONZALEZ REITERATED VELEZ'S CHARGES THAT URIBE FEARS FOR HIS LIFE BECAUSE HE WAS UNABLE TO DELIVER FOR HIS MEDELLIN CARTEL MENTORS.
- 11. FOLLOWING THE PUBLICATION OF ESCOBAR'S LETTER REFERRING TO THE MEETING, THE THREE INVOLVED SCRAMBLED TO PUT THE BEST LIGHT ON THE EVENT. VILLEGAS INSISTED THE MEETING WAS PREVIOUSLY APPROVED BY ALL OF ANTIOQUIA'S CONGRESSMEN, WHICH WAS DENIED BY AT LEAST ONE OTHER CONGRESSMAN, AND WHICH URIBE TOLD POLOFF WAS CONFIDENTIAL

12. COMMENT: WE ARE CONVINCED THAT THE MEETING WAS NOT SANCTIONED BY THE GAVIRIA ADMINISTRATION AND THAT NOTHING EVER CAME OF IT. MOST LIKELY ALL THREE WERE ACTING OUT OF WHAT THEY SAW AS THEIR INDIVIDUAL
